- 6. Establish communication & cooperation bridges with UN agencies, international organizations, etc. alongside governmental and non-governmental entities in KRI & Federal Iraq, with a focus on improving laws and regulations.



2024: a total 88,500 people in need benefitted from our programs nationwide








MAIN HIGHLIGHTS OF OUR WORK



Shelter & WaSH

Sector focuses on shelter and WaSH facilities reconstruction for vulnerable families who almost lost everything during ISIS-Iraq War, including religious, ethnic communities and minorities.

- Shelter Rehabilitation for 175 returnee war-damaged houses (2021, Qaim/Rumanna, Anbar, funded by PRM DoS, in partnership with IOM)
- Durable Housing Rehabilitation for 300 vulnerable families (2019, Beiji, Salah Al-Din, funded by OFDA, in partnership with IOM)
- Durable Housing Rehabilitation for 200 vulnerable families (2018, West Anbar, funded by IOM)
- Shelter Rehabilitation for 417 war-damaged houses (2018, Zanjili/Yarmuk/Maghrebi/Bashiqa, West Mosul - Ninewa, funded by UN-Habitat)



- Rehabilitation of Sada Bawiza and Gogjali Villages (Shabak Minority) - 207 war-damaged houses (2010, Ninewa, funded by UNOCHA ERF - Emergency Response Fund)
- Reconstruction of Wardak Village (Kakai Minority) 262 wardamaged houses (2009, Ninewa, funded by UNHCR)



Food Security & Livelihoods

Sector focuses on local CBOs, youth, women, vulnerable communities empowerment, agriculture in IDP camps, humanitarian assistance to vulnerable communities following ISIS occupation, vulnerable communities job placement or business creation & development.

- Beneficiary Selection, Capacity-Building and Baseline Assessment for 3,501 beneficiaries (2021-2022, Ninewa, Kirkuk, Anbar, Salah al-Din, Diyala, in cooperation with UNDP)
- Youth Innovation & Creativity Award "Khotwa" for 20 winners (2021-2022, Ninewa/Kirkuk, in cooperation with UNDP, funded by the Government of Canada)
- Empowering youth & women returnees (2020, West Anbar, Salah al-Din, Ninewa, funded by UNDP)
- Provision of COVID-19 Life Support Packages "Ahalina Campaign" to 28,470 people in need (2020, Ninewa, Salah al-Din, Anbar)
- Establishment of 8 Green Houses for IDP camps (2017, Bahrka, Erbil, funded by Maas Group Holding)







- Employment Promotion through Skills Development in Khanaqin, Dyala (2024): Supported by UNDP, the project provides vocational training for youth and women, linking them to local businesses.
 270 trainees participated
- Humanitarian Assistance Committee of over 30 local NGOs for over 40,000 IDPs (2014-2016, Ninewa)
- Livelihood & Self-Reliance Program for 1,821 IDPs (2014-2015, in cooperation with UNDP)
- Distribution of food & non-food items to over 50,000 vulnerable communities (Erbil, Duhok, Sulaimanya, Kirkuk, Diyala and Mosul, funded by UNHCR
- The Generation Unlimited Youth Challenge 2023, led by KOHRW and the Ministry of Youth & Sports with UNICEF support, aimed to help young entrepreneurs turn ideas into reality. Out of 300+ teams, 10 joined a 5-day Bootcamp and 2 teams represented Iraq in the global challenge among 50+ countries.
- The Erbil Citadel Enhancement 2023 project, led by KOHRW, UNESCO, and partners, focuses on restoring the Central Alley and visitor routes while empowering the local community through cultural heritage and 15,000 short-term job opportunities.



Peace Building& Social Cohesion

Sector focuses on local CBOs, youth and women groups as an effort to facilitate and improve social cohesion amongst all religious groups, ethnicities, gender & age & other societal differences. Programs aim at establishing dialogue amongst community leaders & encouraging a culture of tolerance, pluralism and mutual respect.

- Empowering over 80 CBOs for social cohesion (2019-ongoing, Ninewa, Kirkuk, Anbar, Salah al-Din, Diyala, in cooperation with UNDP, funded by German Cooperation)
- Establishment and empowerment of over 50 youth & women groups (2021-2022, Ninewa, Kirkuk, Anbar, Salah al-Din, Diyala, funded by UNDP)
- 2025-: support peace initiatives of women groups in Kirkuk and Ninawa 20 groups and unions were supported. program is funded by UNWOMEN.





Advocacy

Legal Reform was improved through the Constitutional Review Program in Iraq, leading to the creation of NGO law in the KRG and the amendment of association law. This also led to the establishment of Alliance of Iraqi Minorities (AIM) to create a new law to protect minorities. To strengthen cooperation between local authorities, NGOs, and Civil Societies, KOHRW has established a pact that provides guidelines on coordination mechanisms.

Human Rights

KOHRW has been, since establishement regularly reporting on human rights violations. This includes monitoring, documentation, issuing reports and follow-up on human rights violations. This activity is not linked with a specific project but it includes: data collection, analysis, recommendations and regular visits to expected locations of human rights violations (detention centers, prisons, juvenile reformatories...etc.)

- Protect Human Right Defenders to promote peace & democracy (2022 - Ongoing, Iraq, funded by the British Embassy)
- Opening the square Protecting the right to peaceful assembly (2021-Ongoing, Iraq, in cooperation with ICNL, supported by DRL-DoS)
- Strengthening Media for Democratization to 500 journalists & security forces (2021-2022, KRI, funded by UNDEF)
- Voter Education Project Building Capacity & Educating over 60,000 Youth to participate in voting process (2021, Erbil/Diyala/Basra, in cooperation with UNDP, funded by UNAMI)



- Monitoring of Iraqi Parliamentary Elections (2018, KRI, funded by DAI - USAID)
- GBV training to 6,440 Peshmerga Officers (2016-2018, KRG, funded by FDFA Foreign Office of the Swiss Government)
- Human Rights and GBV ToT for over 6,000 Security Forces (2018, KRI, Federal Iraq, including the Iraqi Police, the Ministry of Interior, the Ministry of Defense, Peshmerga, other security agencies, funded by FDFA)

KOHRW is a leading organization in protection of vulnerable groups. With support from IOM, it contributed in the creation of the Displacement Tracking Matrix (DTM) of IDPs and ran three (PACs) protection and assistances centers for IDPs, refugees, returnees, and vulnerable groups in Ninawa and Kirkuk providing legal consultation case management for victims, among a pluarity of initiatives since its etablishment.

- Community Support Center (CSC) in Kirkuk, (2025) by KOHRW and UNHCR, provides refugees with legal aid, PHSS, GBV support, and child protection services. Legal Defense
- Center for Migrant Laborers (2017-2020, KRI,funded by UN-OHCHR)
- Distribution of 25,000 Solar Lamps & Mobile Phone Charging Kits to IDPs (2014-2015, Erbil, funded by UNOPS)
- Legal Clinics for IDPs & Refugees (2011-2012, Khabat/Ankawa, Erbil, funded by USAID)
